## **KENTLAND TOWN HALL**

## **TOWN MANAGER**

Ricky Hughes reported on the following:

Ricky asked if rentals will still be available in the evenings with the Nutrition Site starting. Debby responded to yes, rentals can still happen in the evenings, but Jackie Winger will have to check out the Depot to make sure it is clean for the next day. Jackie Winger is not responsible to clean for the Nutrition Site and they will have their own cleaning supplies.

Ricky received two quotes from Anthony Valandingham and Wiseman Tree Service for taking down a tree in the ditch and stumps removed at the baseball field area. Valandingham was at \$2,100 for tree removal and grinding stumps at \$400 each. Wiseman was at \$2,000 for tree removal and \$320 per stump. The Board told Ricky that he could decide which company he would like to use and they will discuss the tree removal at the Conservancy Meeting following this one.

Ricky asked when they wanted the pavilion and concession building removed. Mike responded that they were not in a hurry for them to be removed.

Ricky contacted the company that the cooler was purchased from for the Baseball Concessions and it is not under warranty. It was not brought to their attention in a timely manner so the cost to replace the door and track will be \$359.00 with an additional cost for shipping of \$235.00. A motion was made by Debby Shufflebarger and seconded by Mike Rowe to order the new door.

Tires are needed for the garbage truck. Debby Shufflebarger let Ricky know to go ahead and order.
