**The purpose of this meeting is an Ordinance Workshop. Debby Shufflebarger, read out loud the Fence Ordinance #2023-02-22.**

**Jamie Wirtz, Chief of Police, presented some designs that Vast had put together for stickers on registering golf carts for the 2023 year. Jamie will be checking on a cost to have these produced. Jamie also brought up that there are a lot of homes within the town that do not have house numbers on them. He would like to see an ordinance stating this for the emergency fields so identification will be much easier.**

**Debby Shufflebarger introduced a few ordinances that need corrected:**

**30.17 Regular Meetings – it states in the ordinance book meetings are held on the second Monday of each month at 7:00 P.M.**

**Should be second Wednesday of each month at 5:00 P.M.**

**30.19 Order of Business – it states 7:00 P.M.**

**Should be 5:00 P.M.**

**31.01 Appointed Town Officers – it states (3) Town Engineer**

**Judy King said at one time we used the same Engineer that the County used. Becky will look into this.**

**32.01 Established – it states Economic Development. Debby asked if this was needed since we have a Redevelopment Commission.**

**32.15 Boards – it states Town Conservancy Director.**

**Judy King thinks the President of the Conservancy would also be the Director.**

**Boards – it states Board of Parks & Regulations and also states Park Board. What is the difference between the two and are both needed?**

**32.16 Appointments – Not stated in the ordinance book are Northwest Indiana Solid Waste District or Newton County Economic Development**

**33.04 Water Storage Sinking Fund – possibly the fund for Water Cash Reserve (Emergency Repairs) on the financial statement.**

**The board members would like to see the Golf Cart Ordinance, Building Permit Ordinance and Fees, Small Purchases and Water and Sewer Tap Fee Ordinances corrected and done as soon as possible.**

**Being no further business, a motion was made by Debby Shufflebarger and seconded by Mike Rowe, to adjourn the meeting.**
